



## Exhibitor Liability Insurance Program

The "New York Rights Fair 2018" requires that you must be able to meet any potential liabilities caused by you, your staff or 3<sup>rd</sup> party contractors. According to the NYRF Terms and Conditions (Article 15) of the Exhibit Space contract, as a standard requirement for all show Exhibitors it is necessary to carry general liability coverage from an insurance company in good standing with **minimum policy limits of \$1,000,000 per occurrence and \$2,000,000 aggregate.**

This insurance must be in force during the lease dates of the event, **May 28-June 1, 2018**, and have the following additional insureds: **1. New York Rights Fair LLC; 2. Metropolitan Pavilion and 3. GES.**

**If you do not possess appropriate insurance for this event you will not be allowed to exhibit.**
